Re: Certifying Transfers from Statewide Reserves for 2023-25 Budget

The <u>FY 2023-25 Certification Instructions</u> are now updated to include information on the chart of account segments needed for the statewide reserves in Section 2.2 of S.L. 2023-134.

1. Retiree Benefit Enhancement Reserve Receipt Account– Corrected Number

The original Certification Instructions included the wrong account number for the Retiree Benefit Enhancement Reserve.

- Agencies should use the transfer in account **48T00001**, titled "Retiree Supplement Reserve Transfer In" in NCFS, and Inter-fund 019811 to budget the transfer in of the Retiree Benefit Enhancement Reserve.
- Universities should use state aid account **42910000**, titled "State Aid Retiree Supplement Reserve" in NCFS, to budget the transfer in of the Retiree Benefit Enhancement Reserve.

2. New Statewide Revenue Accounts

OSC has established the following new statewide expenditure and revenue accounts:

- Agency Statewide Revenue Accounts
 - ARPA Temporary Savings Fund: 48062000
 - IT Reserve: 48061000
 - State Fiscal Recovery Reserve Interest: 48049000
 - For use of transfers from State Fiscal Recovery Reserve Interest Only.
 - Sports Wagering: 48060000

Agencies should use 48100001 – Agency Operating Transfer for all other transfers from new statewide reserves. Inter-funds for the statewide reserves are provided below in bullet 4.

University Statewide Revenue Accounts

- ARPA Temporary Savings Fund: 42500140
- IT Reserve: 42500139
- State Fiscal Recovery Reserve Interest: 42500137
 - For use of transfers from State Fiscal Recovery Reserve Interest Only.
- Sports Wagering: 42500138

3. Funding Source

Despite the names, transfers from the ARPA Temporary Savings Reserve and the State Fiscal Recovery Reserve interest are **not** technically federal funds. If using a funding source for these transfers, do not use 3000, the code for federal funds.

4. Inter-Fund

Inter-Fund numbers for transfers from statewide reserves usually start with a zero, followed by the Budget Code. These are the clearing accounts for the statewide reserves and are the appropriate Inter-Fund. For example, the SERDRF Inter-Fund is 019930, while it is 019810 for the Federal Infrastructure Match Reserve. Please do not use the budget code followed by a zero.
