# **Researchers Share Ideas for Responding to State Government Priorities**



#### Dr. Nick Carnes

Professor, Sanford School of Public Policy, Duke University

Dr. Nick Carnes joined the faculty at the Sanford School in July 2011. He is a political scientist whose research focuses on American politics, economic and social class inequality, and political representation. Carnes is currently working on a book that examines the shortage of people from working-class backgrounds in national legislatures around the world.



## **Dr. Julie Edmunds** Director, Early College Research Center, UNC Greensboro

Dr. Edmunds is Director of the Early College Research Center at SERVE, where she leads a team doing research on the early college model and related topics. She has been studying early college and dual enrollment for almost 20 years; her research includes a 17-year experimental study of the impact of early colleges and evaluations of multiple large-scale efforts across the country to apply early college principles to traditional high schools. She is also Principal Investigator of a \$5 million grant examining the impact, implementation, and

cost of NC's dual enrollment program, as well as a grant examining the transferability of college credits earned in high school. Dr. Edmunds also conducts evaluation and research on other school improvement topics using designs ranging from randomized controlled trials to developmental, formative approaches. She has published multiple award-winning articles and has written, with colleagues, a book on Early Colleges as a Model for Schooling.
