

The North Carolina Office of Strategic Partnerships (OSP) develops, launches, and enhances partnerships between state government and North Carolina's research and philanthropic sectors.






OSP works with state agencies across a wide range of issues,

HOW DO PARTNERSHIPS WORK?

Partnerships are tailored to state agencies' needs and priorities, interest from potential partners, available resources, and other considerations. Some partnership opportunities are for short-term engagements of a few months or less; others require longer commitments. Project time frames, deadlines, funding possibilities (if needed), and deliverables are determined case by case. OSP prioritizes partnerships that are scalable, sustainable, and yield opensource knowledge and resources. OSP developed the <u>North Carolina Project Portal</u> to share opportunities for research partnerships with state agencies and for people to express interest in pursuing those opportunities.

WHAT ARE SOME EXAMPLES OF PARTNERSHIPS?

WHAT IS THE EVIDENCE ADVISOR'S ROLE INSIDE STATE GOVERNMENT?

The North Carolina Office of Strategic Partnerships (OSP) created the Evidence Advisor role to help state agencies generate and use evidence. This role supports OSP's core work of increasing state government's use of research and data by building internal capacity for evidence-based decision making. OSP's Evidence Advisor supports state agencies by:



HOW DOES THE EVIDENCE ADVISOR PARTNER WITH STATE AGENCIES, RESEARCHERS, AND PHILANTHROPY?

The Evidence Advisor provides additional research and evaluation capabilities for state agencies and philanthropies that do not have dedicated resources or staff to conduct research and synthesize evidence. The Evidence Advisor also works with external research partners to develop research projects that answer agency priority questions. The role is flexible to support state agencies in whatever way it can to help OSP's cross-sector partners generate and use evidence.

WHAT DOES THE EVIDENCE ADVISOR DO?

The Evidence Advisor works with state agencies to:

- Support the development of agency research agendas and identification of agency priority questions.
- Provide research and evaluation capacity by leading and supporting agency research and data analysis projects.
- Conduct evidence reviews and research syntheses assessing the quality of the available evidence on the effectiveness of one or more related programs or interventions, with a goal of determining which interventions have demonstrated effectiveness to inform policy and budgetary decisions.
- Build state agency research and evaluation capacity to generate and use evidence through in-person and virtual training.

HOW CAN I LEARN MORE?



WHAT DOES THE PHILANTHROPY LIAISON DO?

The <u>Philanthropy Liaison</u> helps build, strengthen, and institutionalize relationships between North Carolina state government and the philanthropic sector.

The Liaison helps state government and philanthropy identify potential opportunities to leverage resources (including, but not limited to, expertise, relationships, and capital) and broker strategic partnerships for greater impact. The Philanthropy Liaison is not a fundraiser for the state. The position focuses on facilitating connections between state government and philanthropy, convening partners across the two sectors, and strategizing on cross-sector collaboration opportunities.
