North Carolina General Statute 150B, also referred to as the Administrative Procedure Act (APA), establishes the rulemaking and adjudicatory procedures for State agencies. The Statute defines a "rule" as:

...any agency regulation, standard, or statement of general applicability that implements or interprets an enactment of the General Assembly or Congress or a regulation adopted by a federal agency or that describes the procedure or practice requirements of an agency.

Nearly 20 percent of the national economy is regulated by the states.¹ State rules cover a wide range of actions, from nitrogen levels in local lakes to training standards for law enforcement. Recognizing the growing importance of rules and their direct impact on business and citizens, the Governor signed Executive Order No. 70, *Rules Modification and Improvement Program*, on October 21, 2010. Executive Order No. 70, part of the Governor's *Setting Government Straight* initiative, outlines regulatory principles intended to guide North Carolina's rulemaking.

Executive Order No. 70 also directs the Office of State Budget and Management (OSBM) to coordinate and oversee the Rules Modification and Improvement Program (RMIP) and publish an annual report on its progress. The RMIP is intended to evaluate, reform, expand, or, where necessary, repeal existing rules and associated requirements that are unnecessary or unduly burdensome. To accomplish these goals, the RMIP was required to solicit input through two separate paths:

- 1. Invite comment on whether any existing rules, implementation processes and associated requirements are unnecessary, unduly burdensome, or inconsistent with the goals of this Executive Order. Comments may include modifying, expanding, or rescinding existing rule programs or the rule review and publication process.
- 2. Direct agencies to undertake an internal review to identify existing rules and associated requirements that are unnecessary, unduly burdensome, or inconsistent with the goals of this Executive Order.

The remainder of Part 1 of this report discusses the RMIP progress. The Public Comment section of this report details the progress made on Section 1 listed above, while the Internal Agency Review section of this report provides a complete update on Section 2. As required by Executive Order No. 70, Part 2 of this report also includes recommended improvements to the rule process and accompanying analysis.

PUBLIC COMMENTS

As mentioned above, the RMIP requested public comment on specific rules, implementation processes and associated requirements that are unnecessary or unduly burdensome. Through March 2011, 1,622 public comments were submitted in response to the solicitation. Consistent with the direction in Executive Order No. 70, OSBM gave highest priority to comments submitted earliest in the process. While comments

received most recently did not inform this report, the vast majority (1,327 comments) were evaluated.

After receiving the comments, OSBM evaluated whether each comment (1) was rule-related and (2) may have potential merit. Of the 1,327 total comments evaluated, 250 comments were determined to be rule-related and have potential merit. A large majority of the comments addressed programs administered by the Department of Environment and Natural Resources (DENR), Department of Health and Human Services (DHHS), and the Department of Administration (DOA) (see Table 1). OSBM instructed agencies to review the merits of each of the 250 comments and prepare a response for OSBM by January 31. The response was to include a determination of whether further action was justified.

OSBM reviewed the comments and agency responses, collaborated with agencies and outside experts, and determined that 224 of the 250 comments justify further action. Further actions generally fall into two categories: amend programs and study issues further. Amending programs can range from changing agency rules, policies, or guidance to pursuing statutory change. Table 2 summarizes the 250 comments and recommended action. It should be noted that OSBM and agencies do not necessarily agree with all public comments or the solutions suggested by commenters.

INTERNAL AGENCY REVIEW

As part of the requirements stated in Executive Order No. 70, the Rules Modification and Improvement Program (RMIP), cabinet agencies have two major responsibilities:

- 1. to conduct an internal review of agency rules to identify existing rules that were unnecessary, unduly burdensome, or inconsistent with EO 70, and
- 2. to make a recommendation as to whether these rules should be repealed, modified or expanded.

As a result of this review, agencies identified 2,080 rules for repeal, modification, or expansion. Table 3 shows the disbursement of the 2,080 by rule type and agency grouping.

REPEALS

Of the 1,064 rules identified for repeal, 895 were submitted to the NC General Assembly for repeal on February 8, 2011. An additional 164 rules identified for repeal will be submitted to the NC General Assembly shortly.

When an agency proposes a new rule it usually goes through a review process by three different organizations. First, the Office of State Budget and Management (OSBM) reviews the estimates of costs and benefits provided by the agency. And, if it is a cabinet agency, OSBM reviews the rule for principles articulated by the Governor. After public comment, the Rules Review Commission reviews the rule for statutory authority and clarity. Finally, if ten members of the public object to the rule, the rule is formally reviewed by the legislature. The process is outlined in the North Carolina Administrative Procedures Act (APA) and Executive Order No. 70.

Recently, the Institute for Policy Integrity (IPI) released a report grading state level regulatory review processes.² The average grade given to states was a D+, with the highest grade, a B+, given to the state of Iowa. North Carolina received a C+. North Carolina scored higher than average for the balance and rigor of the state's economic analysis of rules and received praise as a national best practice in this area.³ However, the report cited issues with not having a process to review existing rules, delay and burden in rulemaking, and lack of transparency.⁴ Executive Order No. 70, issued after the IPI report was published, and recent actions by the NC General Assembly, largely address the concern regarding the review of existing rules. The executive order outlines a clear process for an annual review of existing rules. However, the delay and burden in rulemaking and lack of transparency. It also provides information and analysis on related concerns and makes recommendations on improvements to the rulemaking process in North Carolina.

DELAY AND BURDEN IN RULEMAKING

The APA process is often considered cumbersome, certainly from the perspective of the public.⁵ It is also difficult on agencies (see chart 1 on the timeline for review of rules with fiscal notes). This has led to unfortunate effects which are discussed in more detail below.

The IPI Report cites a number of best practice-based principles to inform state regulatory review. They include not spending more resources reviewing a rule than necessary given the rule's relative importance, and not delaying a rule unnecessarily through a review process. Besides simply creating inefficiencies, delays can undermine the entire review process. According to the report,

unnecessary delays can lead agencies to "less transparent, less reviewable means of rulemaking such as . . . guidance documents."⁶ If the rule review process is not proportional and appropriate, it can lead agencies to find alternative methods to make "rules."

EXEMPTIONS AS EVIDENCE OF DELAY AND BURDEN

The APA statute provides for both full and partial exemptions from the rulemaking process in some cases. In addition, the statute specifies certain statements, policies, plans, procedures, etc. that are excluded from the definition of a "rule." Table 8 lists 24 exemptions that relate to particular agencies and are authorized under the North Carolina statute. The table also compares the North Carolina exemptions to those specified in Iowa (four exemptions), which, as noted above, was rated by the IPI Report as having a reasonable balance in the review process. Follow-up interviews with rulemaking officials in Iowa confirm relatively uniform satisfaction with the process. Reviews have found that a "significant minority of North Carolina administrative agencies" have sought exemptions from the rulemaking process because it is too burdensome.⁷ Thus, in North Carolina, the higher prevalence of exemptions is evidence of the difficulty of the current rule review process.

Unfortunately, the exemptions listed below do not illustrate the full picture because they only represent the exemptions explicitly included in the APA. Often the particular statutory authorization will grant an exemption to the rulemaking process.⁸

EXAMPLES OF IMPLEMENTING GUIDANCE AND POLICY DOCUMENTS

It is unknown how many guidance and policy documents are in use by agencies. Since they do not go through a central review process it would be difficult to find, organize, and analyze such documents. As a result, it is also unknown how often guidance and policy documents are implemented properly and how often they are used by agencies to circumvent the rule review process. As examples, OSBM analysts reviewed the guidance and policy documents for three agencies that do not have an APA-based exemption, specifically, the Office of the State Controller (OSC), the Office of Information Technology Services (ITS) and the Department of Administration State Surplus Property (SSP).

ITS appears to only have rules for Information Technology Procurement. However, they have statutory authority over IT security and IT project implementation, amongst other areas. These areas are covered by guidance and policy documents (<u>https://www.scio.nc.gov/mission/default.aspx</u>) that are difficult to find, are not well organized, and have a varying level of clarity. OSBM could not find any statutory exemption that would allow ITS to enforce its authority through guidance and policy documents.

OSC does not appear to have any rules. They do have a large number of guidance and policy documents (<u>http://www.osc.nc.gov/forms_policies/index.html</u>) that appear well organized, clear, and easily accessible. This is certainly a better situation than the guidance and policy documents at ITS. However, there is no connection between the OSC policies and APA rules, making it difficult to search or analyze related policies and rules across agencies.⁹ The state of Iowa has identified the relevant policies on the legislative rule website and includes a link from the APA to the accounting rules website. This informs the public which rules affect them and allows the state to provide the information in a cost-effective manner. OSBM could not find any statutory exemption that would allow OSC to enforce its authority through guidance and policy documents.

SSP seems to create rules on a regular basis. In addition, it also creates guidance and policy documents related to the rules. Whether the guidance and policy documents are properly implemented is difficult to determine. OSBM identified at least 15 policies on the SSP website which may be considered "rules." In evaluating SSP polices, OSBM categorized each as either: 1) augmenting, 2) being different than, or 3) following the rules (with more specificity). Table 9 shows this breakdown.

PROBLEMS WITH EXEMPTIONS AND GUIDANCE DOCUMENTS

A glut of exemptions and guidance documents is problematic for a variety of reasons. First, bypassing the rule process generates less effective policy, as public comment and economic and legal reviews are inconsistently implemented. Second, it creates arbitrary government. When rules are put in place separate from the APA rulemaking process, they are not subject to notice and comment and may be inconsistently communicated or hidden on agency websites or bookshelves. Such hidden rules are often inappropriately enforced as law. When rules are not clearly available in a single location, economic and democratic principles can be undermined, as it creates uncertainty for businesses, inhibiting job growth, and creating the appearance of favoritism when hidden rules are inconsistently applied.

These issues were specifically identified by the public during the review of existing rules (Part 1 of this report). Chiefly, public commenters registered complaints regarding the lack of clear APA rules at ITS. Attorneys who represent clients before the Department of Revenue and the Employment Security Commission (ESC) also commented about rules and guidance documents in those agencies that bypassed the APA process, never received public comment, and seemed arbitrary.

One tangible impact of using guidance documents and policies instead of rules is the lack of legal enforceability. OSBM reviewed a sample of lawsuits against the state that were based on questions of policy authority. These lawsuits could have been entirely or partially eliminated if state agency policies had been adopted into law through the rulemaking process.

In *McCrann v. DHHS*, filed in the Court of Appeals on January 18, 2011, the Court affirmed the Wake County Superior Court's decision finding DHHS's denial of benefits to be "arbitrary and capricious." It cited an earlier case (*Dillingham v. NC Dept of Human Resources*) which found the State Adult Medicaid Manual was invalid because it had not been adopted in accordance with Article II of the APA. The *McGrann vs. DHHS* legal dispute lasted for almost 5 years, costing the state an estimated \$190,000 in expenses due to additional staff time and the \$23,000 settlement awarded by the court. This estimate excludes private attorney fees.

In *Dillingham v. NC Dept of Human Resources* (DHR), filed April 6, 1999, the Court of Appeals stated that a requirement in the North Carolina "Aged, Blind and Disabled Medicaid Manual" to provide clear and convincing written evidence was invalid because the requirement was not implemented through the rule review process. Medicaid coverage had been denied by the DHR in November, 1996.

TRANSPARENCY AND TECHNOLOGY

As briefly mentioned earlier, transparency in the rulemaking process is very important for several reasons. A transparent process often involves a consistent evaluation of the costs and benefits of rule changes, and communicating important regulatory information to impacted and interested parties. It also likely follows the APA rulemaking process, resulting in more consistent rules that are easily accessible in a central location. Given these clear benefits of transparency, many other

states and the federal government are leveraging technology to improve transparency in the rulemaking process.

While technology cannot transform a poor or confusing process into a streamlined and efficient process, it can smooth out a number of rough edges. In particular, it can take information from separate organizations (like OSBM, the Rules Review Commission, and the General Assembly) and make it appear as part of one process to the public. A 2008 Duke Master's Project on e-rulemaking in North Carolina corroborated these benefits of technology in the rulemaking area.¹⁰ The study found the current rule process was inefficient, required duplicative paperwork, and relied far too much on individual agencies disclosing where rules are in the process.¹¹ It recommended a process for developing an e-rulemaking system to solve some of these problems and focused on the federal system (<u>www.regulations.gov</u>) and the Virginia Town Hall system (<u>townhall.virginia.gov</u>) as possible examples. The more recently issued IPI Report points to Utah's Division of Administrative Rules website as a model of transparency.¹²

RECOMMENDATIONS

- 1. Reduce the number of exemptions Exemptions allow agencies to shift important rules away from an APA rule process intended to provide the public a meaningful opportunity to participate in the process. The APA rule process also ensures rules are informed with rigorous and accurate analysis.
- 2. Streamline the rulemaking process Of the thousands of rules implemented every year, very few have a significant economic impact and trigger review by the NC General Assembly. Requirements should be proportional to the size and importance of the rule.
- 3. Improve oversight of guidance and policy statements from the agencies Inappropriate use of guidance and policy statements as rules adds legal risk to agencies, frustrates public involvement in the rule process, and creates inconsistencies in application of legal and economic reviews.
- 4. Implement a technology solution Leveraging technology in the rulemaking process could improve the transparency of the process, organization of regulatory information, and citizen participation.
