**What Is It?**

Reflects the line item account or object from the Uniform Chart of Accounts and the Account Title from IBIS (updated from NCAS nightly).

**What To Do With It?**

Ensure the funds, account numbers and account titles are correct. Contact your OSBM analyst if corrections are needed.

**Notes on the Authorized Budget and Budget Revisions:**

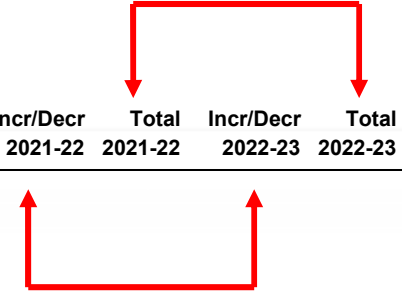
- After the initial inclusion of recurring budget revisions into the base budget (October 1, 2020), any budget revision to be included in the base budget must be manually included by OSBM. Budget revisions included in the base budget in error must be manually excluded by OSBM.
- No carry forward budget revisions may be included in the base budget.
- The 2020-21 authorized budget in the base budget document will not match the SFY 2020-21 authorized budget in NCAS. The authorized budget in the base budget document includes budget revisions that are specifically included in the base budget, while the NCAS authorized budget includes all budget revisions approved in SFY 2020-21.
