SUBJECT: Required Quarterly Report on State Capital and Infrastructure Fund (SCIF) Grants

Per S.L. 2021-180, section 40.8, as amended by S.L. 2021-189, S.L. 2024-1 and S.L. 2024-57, the Office of State Budget and Management (OSBM) is required to report to the Fiscal Research Division quarterly on the schedule and status of grant disbursement for State Capital and Infrastructure Fund (SCIF) grants to non-state entities, including the following for each grant:

- a. The date which the disbursing agency issued the initial contact.
- b. The date when the contract was sent to the grantee non-State entity.
- c. The date when the fully executed contract was returned to the disbursing agency.
- d. The date when the contract was executed.
- e. The date when a grant was disbursed in full.

Attached please find a listing of the 918 SCIF grants with each of these dates indicated. Of the 918 SCIF grants, 788 are administered by OSBM, 101 are administered by the Department of Public Instruction (DPI), and 29 are administered by the Department of Transportation (DOT). OSBM entered MOUs with DPI and DOT to govern the administration of the SCIF grants that were allocated to them; we are also monitoring their grant programs. DOT and DPI have administrative responsibilities for their grant process and oversight and monitoring of their grantees.

In summary, OSBM has disbursed 785 SCIF grants. There are three grantees for whom we are waiting on one (or more) of five legislatively required documents. Over the past three months, OSBM has continued to monitor grant recipient's projects and use of funds, collect required documentation to administer grants and provided training opportunities to inform grantees of the reporting process.

Our office has been working tirelessly to manage the 1,485 current grants administered by our office. In addition to disbursing new grant funds, the five-person Grants Team continues to provide technical assistance related to reporting, monitoring, and auditing for directed grant recipients. We have continued to hold webinar training courses and Q&A sessions. With the addition of more than 1,000 new grants in the most recent budget—and the continued transfer of additional grants to our office for administration—we require additional resources and staff to effectively fulfill our responsibility to prevent fraud, waste, and abuse of state tax dollars.
