SUBJECT: Required Quarterly Report on Directed Grants to Non-State Entities

Per S.L. 2023-134, Sec 5.3.b, as amended by S.L. 2024-1, S.L. 2024-57 and S.L. 2025-4, the Office of State Budget and Management is required to submit a quarterly report on directed grants administered by our office:

(3) Beginning on the first day of a quarter following the deadline provided in subdivision (2) of this subsection and quarterly thereafter, State agencies administering directed grants shall report to the Fiscal Research Division on the status of funds disbursed for each directed grant until all funds are fully disbursed. At a minimum, the report required under this subdivision shall include updates on (i) the date of the initial contact, (ii) the date the contract was sent to the entity receiving the funds, (iii) the date the disbursing agency received the fully executed contract back from the entity, (iv) the contract execution date, and (v) the payment date.

Please see the attached spreadsheet answering these questions for each grantee for the quarter ending June 30, 2025. In summary, of the 926 directed grants to Non-State Entities for FY 2023-24, 97% of the grant contracts legally ready (895 of 926) have been fully executed and funds disbursed.

Session Law 2025-4 became law on May 14, 2025, which added 11 new grants for our office to administer.

Our office continues to assist the remaining grantees in submitting the five legislatively required documents - W-9; electronic payment form; conflict of interest policy; sworn statement re: no overdue tax debts; and a scope of work outlining how their grant funds will be used.

As part of the OSBM Directed Grants portfolio, \$200,000 was appropriated to be allocated to the Register of Deeds by application. The application process was completed at the end of April. Only 43 Register of Deeds applied, of which all 43 grantees have received the initial round of grant funds. 41 applicants were interested in receiving a second round of funding, and all the second round funds have been disbursed.

In addition to disbursing new grant funds, the five-person Grants Team at the Office of State Budget and Management continues to provide technical assistance related to reporting, monitoring, and auditing for directed grant recipients. We have continued to hold webinar training courses and Q&A sessions. With the addition of more than 1,000 grants in the last budget, we are in need of additional resources and positions to ensure that we can meet our responsibility to prevent waste, fraud and abuse of state tax dollars.
