The purpose of this program is to provide matching funds for mobile broadband providers to deploy infrastructure to extend coverage or enhance the capacity of the Public Safety Broadband Network to unserved and underserved State agency campuses. The Department shall determine the match rate for each campus based on the ability of each campus to provide funding based on the Department's criteria. Mobile broadband infrastructure funded under this subdivision shall be capable of utilizing the Band 14 spectrum.

#### Update narrative:

This program is housed in the NCDIT Division of Broadband and Digital Opportunity's FirstTech Program and piloted with the Samarcand Training Academy campus. NCDIT is working with the vendor to firm up the contract vehicle that will be used for the installation of the cellular equipment. This could include an amendment to state convenience contract 915A for cellular services though we also exploring a Request For Quote in parallel as the master agreement for 915a was originally designed for cellular service.

The State Property Office conducted an open Request for Proposal process, and a tower builder is under contract to build the tower at Samarcand at no cost to the State while generating revenue to the State on the land lease. The cellular vendor has established a relationship with the tower builder and will become one of the tenants of the tower. This funding will be used for the cellular vendor to install the needed equipment on the tower. The site plan has been completed, and the tower builder is working with Moore County and other authorities to complete the permit and application process.

NCDIT funded NC DPS to purchase of a deployable cellular tower that can used in targeted areas around the Samarcand campus for temporary cellular coverage as needed. This

equipment assists with the immediate needs during select courses, while the permanent tower is being constructed as a long-term solution.

Things are moving forward, and we anticipate the cellular equipment installation to happen in the spring of 2026 after the tower is built. NCDIT is working with other state agencies to identify additional sites that can benefit from this process.
