SUBJECT: New Grant Award

Pursuant to G.S. 143C-5-4(9) the Office of State Budget and Management (OSBM) submits the attached Notification of Grant Award (BJA FY 23 OJP Community Based Violence Intervention and Prevention Initiative) for consultation with the Joint Legislative Commission on Governmental Operations.

The NC Department of Public Safety Governor's Crime Commission has been awarded the FY 2022-2023 BJA FY 23 Office of Justice Programs Community Based Violence Intervention and Prevention Initiative grant. The award amount is \$4,000,000. Pending consultation with Gov Ops, the start for the award will be 10/1/2023 and the award will have a duration of 36 months. The award does not require a match obligation.

OJP's Community Based Violence Intervention and Prevention Initiative (CVIPI) seeks to prevent and reduce violent crime in communities by supporting comprehensive, evidence-based violence intervention and prevention programs, including efforts to address gang and gun violence, based on partnerships among community residents, local government agencies, victim service providers, community-based organizations (CBOs), law enforcement, hospitals, researchers, and other community stakeholders.

The State of North Carolina, through the Department of Public Safety and the GCC, will utilize CVIP funds to enact a multidisciplinary approach in rural, marginalized communities with high violence data. It will fund TTA to build capacity for successful Community Violence Intervention (CVI) initiatives, expand capabilities through collaborative support of evidence-based best practices in the prevention and reduction of crime in communities by supporting comprehensive, evidence-based violence intervention and prevention programs. Moreover, it will also fund CVIP programs in rural communities.

OSBM has approved this new funding and submits the notice of Grant Award for consultation.
