SUBJECT: Required Quarterly Report on State Capital and Infrastructure Fund (SCIF) Grants

Per S.L. 2023-134, section 40.7, as amended by S.L. 2024-1, S.L. 2024-57 and S.L. 2025-4, the Office of State Budget and Management (OSBM) is required to report to the Fiscal Research Division quarterly on the schedule and status of grant disbursement for State Capital and Infrastructure Fund (SCIF) grants to non-state entities, including the following for each grant:

- a. The date which the disbursing agency issued the initial contact.
- b. The date when the contract was sent to the grantee non-State entity.
- c. The date when the fully executed contract was returned to the disbursing agency.
- d. The date when the contract was executed.
- e. The date when a grant was disbursed in full.

Please see the attached spreadsheet outlining answers to these questions for each grantee for the quarter ending December 31, 2025.

In summary, OSBM reached out to all 60 grantees to request the statutorily required documents they have to submit prior to the disbursement of their grant funds. Of the 60 grants, OSBM has administered 59. There is 1 grantee for whom we are waiting on one (or more) of the five legislatively required documents - W-9; electronic payment form; conflict of interest policy; sworn statement re: no overdue tax debts; and a scope of work outlining how their grant funds will be used.

The OSBM Grant Team currently consists of a Grant Manager and four Grant Administrators. OSBM received a new grant program, and, along with the continued transfer of additional grants to our office for administration, our office has been working tirelessly to manage nearly 1,500 current grants administered by our office during the past quarter.

In addition to disbursing new grant funds, the five-person Grants Team at the Office of State Budget and Management continues to provide technical assistance related to reporting, monitoring, and auditing for directed grant recipients. We have continued to hold webinar training courses and Q&A sessions. We continue to require additional resources and staff to effectively fulfill our responsibility to prevent fraud, waste, and abuse of state tax dollars.
